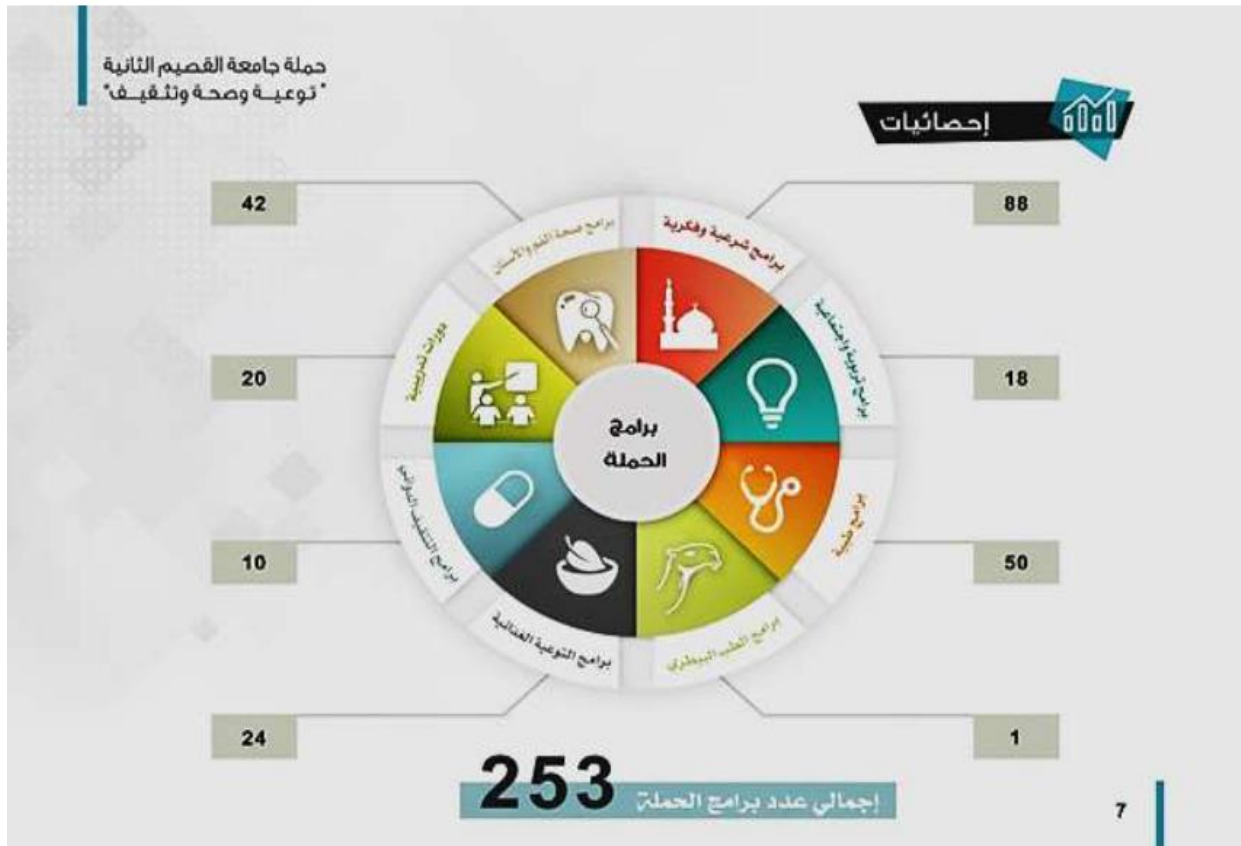


Figure (9) Qassim University's second campaign "Awareness, Health and Education" in Uqlat Al-Suqur Governorate

Veterinary Medicine Programs -8-5-1

In order to serve the livestock in the Aqlat Al-Suqur area, the Veterinary Medicine Department at the College of Agriculture and Veterinary Medicine organized a veterinary convoy next to the campaign camp on Saturday 6/22/1439 AH to detect, diagnose and treat animal diseases, in addition to providing veterinary consultations.

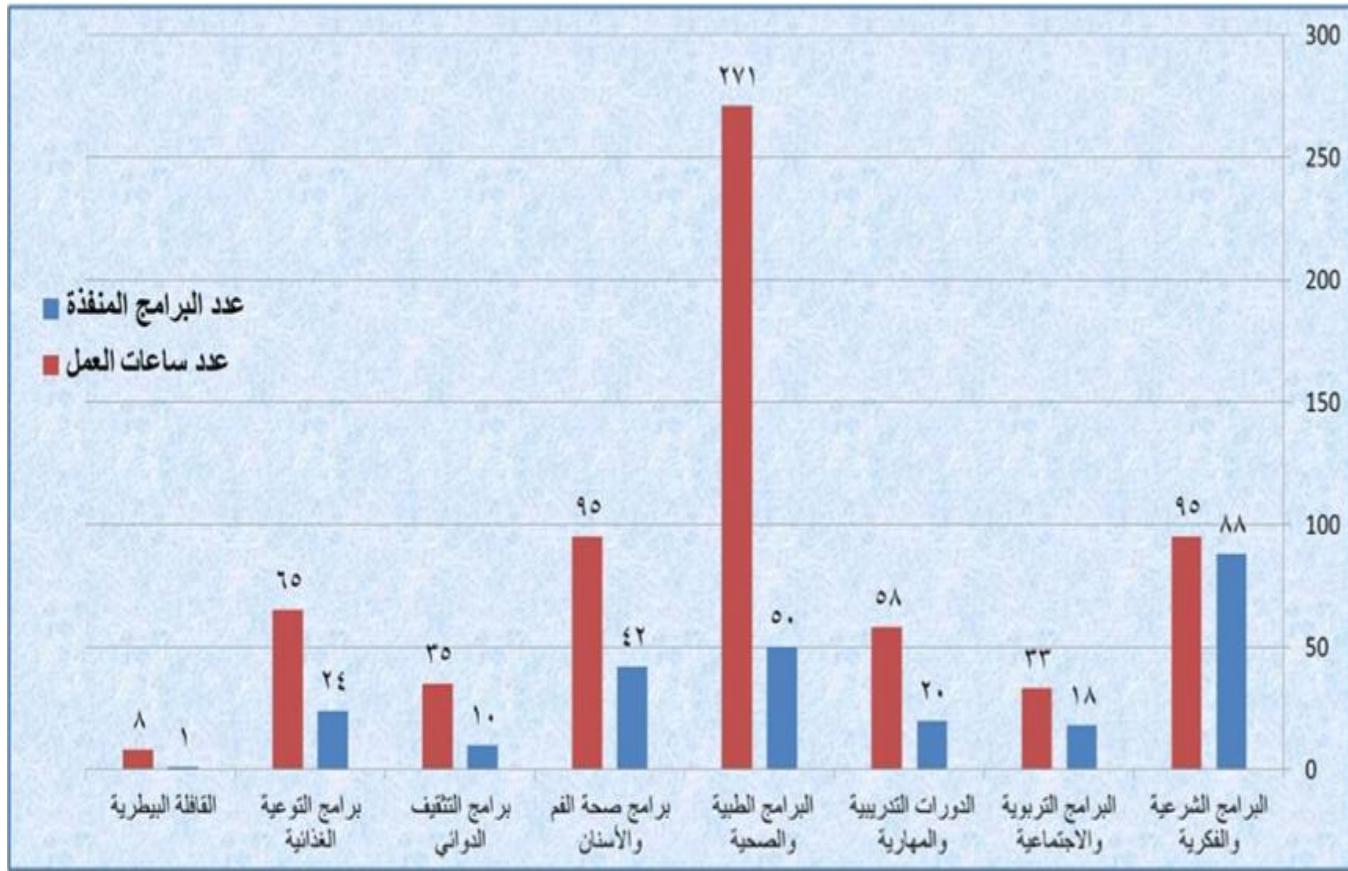

Rehabilitation of prisoners has become a matter of great importance. There is no benefit in combating criminal behavior by merely placing the prisoner in correctional institutions without rehabilitating him before leaving them. The prisoner needs to be taken by the hand to return to society. Experience has proven that therapeutic, rehabilitation and educational programs in prisons are more useful and effective in combating criminal behavior than simply placing the prisoner in penal institutions without rehabilitating him before leaving the correctional institution.

Education is an important element necessary in the field of rehabilitating prisoners. Education helps the prisoner get rid of ignorance and illiteracy, raises his intellectual level and thus matures his mental abilities and provides him with confidence in himself and in his ability to act properly and solve all the problems he faces in appropriate ways. The educational programs inside prisons aim to raise the level of reform programs provided in these institutions and support the inmates of these institutions with capabilities, skills and knowledge that help them integrate back into society. From this standpoint, university education inside prisons is of great importance in returning this group to a sound social environment as good citizens who contribute to giving and offering in the fields of goodness, security and stability. Based on the above, and based on the principle of partnership, cooperation, community services and national duty that Qassim University adopts in its relationship with various parties in the public and private sectors, and in line with its strategic goals and plans to play an influential and effective role in development work, in the scientific, educational and community service fields, an agreement was reached between the university and the Presidency of State Security to cooperate in the field of rehabilitating and reforming detainees in security cases and integrating and involving them in society in a safe and effective manner.
